## Re. ELECTION OF PARENT GOVERNOR

I wish to inform you that we now have three vacant positions for Parent Governors on the Governing Body of Ysgol Gyfun Garth Olwg. As defined by Section 2 of the Children Act 1989 " 'Parent' in this context refers to the person with parental responsibility for the child as well as anyone else who has care of him/her".

The role of Governor is an important one, as Governing Bodies are responsible for undertaking a variety of functions connected with the effective running of the school, including curriculum, budgeting and staffing matters.

Meetings of the Full Governing Body must be held at least once per term, Committee meetings are convened, at the most, once every term. All meetings are usually held at the School. In certain circumstances Governors may claim travelling expenses for attendance at meetings.

When elected, a Parent Governor may serve for a period of four years, and is not required to stand down if their child(ren) leave the school. The Authority will provide relevant support, information and training relating to the rights and duties of Governors. It is expected that new Governors will undertake a foundation course consisting of six two hour sessions within the first year of their Governorship. All training is free of charge to Governors and is delivered at local venues.

Should the number of nominees exceed the number of vacancies, ballot papers will then be prepared and distributed by pupil post, together with an envelope marked with a school stamp in which the papers are to be returned to the school.

We would encourage parents to put their name forward for this vital role. To be considered for election, please complete the nomination form as set out overleaf and return it to the **Head Teacher of Ysgol Gyfun Garth Olwg no later than 12.00 noon, Friday, 8<sup>th</sup> of July, 2016**. Any applications returned after this date will **not** be considered.

**NOTE: DISQUALIFICATION FROM SERVICE AS A GOVERNOR**

Appointment as a governor is subject to certain regulations, which disqualify persons from becoming governors. Those **not** eligible to serve in this capacity are:

- (a) a person suffering from a mental disorder from which he/she is liable to be detained under the Mental Health Act 1983;
- (b) a person aged under 18;
- (c) any person who is already a governor of two maintained schools, except as an additional governor of a school in special measures, or as a member of a temporary governing body;
- (d) a governor who without the consent of the governing body has failed to attend a meeting of the governing body for a period of six months from the date of the last meeting he/she attended;
- (e) anyone who has been adjudged a bankrupt until he/she has been discharged;
- (f) anyone who is disqualified under the Company Directors Disqualification Act 1986, or who has failed to make payments required by a county court administration order under the Insolvency Act 1986;
- (g) a person who has been removed from office in a charity by order of the Charity Commission or the High Court, because of mismanagement or misconduct for which he/she was responsible;
- (h) a person who is subject to a direction issued by the Secretary of State under s142 of the Education Act 2002, including a direction given that he/she is included on the list of persons considered unsuitable to work with children under s1 of the Protection of Children Act 1999;
- (g) disqualified from working with children under the Protection of Children Act 1999 or is subject to a direction under s142 of the 2002 Act, or s28 and 29 of the Criminal Justice and Court Services Act 2000;
- (h) any person with a criminal conviction who: within the last five years has received without option of a fine, a prison sentence of not less than three months; within the last twenty years has received a sentence of not less than two and a half years; at any time has received a sentence of not less than five years, or has been convicted for making a nuisance on the premises of a maintained school under s547 of the Education Act 1996; any person who has been declared unsuitable to be the proprietor of or teacher in an independent school under s470 or s471 of the Education Act 1996;
- (i) a person who refuses to apply for a criminal record certificate under s113 of the Police Act 1997 after having been requested to do so by the governing body.
